- a. Tsaille Health Center: Mrs. Tsosie, reported the process of Medicaid and its services. Medicare at age 65 if you do not by 65 you will be charged a 10% penalty. There is 2 parts to Medicaid. Part A and Part B with dedication monthly rather you go services or not. It is up to you to apply for the benefits. This is an insurance coverage that can be utilized anywhere in the US without expiration. The Part B if you have ACCESS that works together. Prescription coverage is all different, if you apply to one it will hinder Medicare.

#### Questions:

What happened to Indian Health Services? Why back 1868 government change to date now they are telling us get other services. Government turned and need to get insurance for people. Government can't pay everything for us anymore.

How does this play into the Obama Care? He raised eligibility to where almost everybody can get the services.

Change in the Social Security is taking more and went outside Navajo for surgery, is there a percentage that I should be responsible for. Yes, ACCESS will pay 80% and you are responsible for 10%.

Medicare will only pay 80% of approved services.

When a person is hospitalized and its expensive. Contract Health is there for people that does not have insurance. That is where Affordable Care came in Medicare/Medicaid is good but does not take care of everything.

Any type of education is need here for awareness.
