**2. Tsaile/Wheatfield Chapter Rural Addressing Project**

A. Introduction/Update on CLUPC efforts to date

Marjorie Johnson provided information on the purpose of the Rural Addressing project to identify and document pertinent data that would permit first responders, i.e. Police, Ambulance, Fire Department and others, to respond to emergencies at any location within Tsaile/Wheatfields community. CLUPC efforts, challenges and issues were covered with intent of Work Session to complete data sheets and identify all structures within

Tsaile/Wheatfields Chapter boundaries, confirming residents and GPS listing. The completed information will be utilized to name all Roads in accordance with Navajo Nation Addressing Authority guidelines.

**B. Review of Data Sheets**

The data sheets were divided among Work Session participants to cross check information. Kuhyonre Nata'ani, Devon Begay and Michelle Jackson took the first portion from the beginning of data sheets to identified and confirm residents. Marjorie Johnson worked with Daniel Staley to confirm information for the Black Rock community. Their efforts identified several chapter members not listed on the data sheets. Lucinda Davis and Margie Begay worked with Charles Chee to confirm data sheets for the upper Wheatfields area. Their efforts identified residents not on the data sheets and also confirm people who were deceased and the names of present residents.

Areas remain that have not been confirmed and will be completed at the next Work Session.

A motion was made by Margie Begay to defer remaining areas of Item B – Review of Data Sheets, C - Road Naming, D – Confirm date for Work Session with MC Baldwin, E – Development of Scope of Work for Installation of Signs, #3 – Tsaile/Wheatfields Community Land Use Plan Manual Revisions to the next work session, seconded by Marjorie Johnson. The motion was passed by a vote of 3 in favor, 0 opposed and 1 abstention.
