Performance Reporting not being done. Project completion (outside) Sales Tax not remitted on time (Jan – Dec) quotes. Form 600 goes to window rock. 5% to Window Rock. Make payment on Form 600. This is down after the fact. Not in timely matter but this is corrected.

Last Issue: Chapter financial not done in her absent. Minutes shows only detail to actual reported. This was neglected no presented.

In the regular meeting to legislate by resolution need to accept the corrective action. Turn around 2 weeks with attorney, 5 days comment period, RDC to view and accept first, then to B&F for final say with plan of operation. Chapter might be given 1 year time frame.

Questions/Comments:

Willis Becenti: cash receipt report 66 months is not enough Red flag all over it. This official should have seen this. Monies that did not get deposit. Why didn't you check 6 months before and 3 months after the report?

We asked for a comprehensive report, audit report page 1 – Budget to Actual. Secretary/Treasurer should have check with the CSC. Someone dropped the ball. I have the minutes and Budget reported that I asked for and copies for me which I am reading now. We need to get this report done. The high risk-low risk has a budget of \$50,000.00 this can be used for comprehensive investigation. We need to move this to Ethics and Rules and private investigation at about \$200,000.00 and we can use the \$50,000.00 we can move to auditor general to move on it.

Mr. Jumbo: Audit Plan can only look so far with developed audit scope. They didn't chose the scope.

Adella Begay: How can you the person is no longer here and the money is a lot of money that is missing. Margie why didn't you check and be on top of this, where was everybody and everyone should be accounted and make sure things like this does not happen. The other thing is Sales Tax will we be penalized?

Mr. Jumbo: Chapter did make payments on time according to set calendar year. Chapter will only pay \$50.00 fee for Sales Tax.

Chapter President: I was the one that made the report and when the MIP system was checked with possible suspected manipulation.

Angie Brown: 4 years ago starting coming to chapter meetings. You (pointing at Officials) were not effective. You were not doing your job. You should come to the meeting early and prepare yourself. When we ask for budget it was not given to us.

This corrective action why given them another chance? We need to give to our elderly- roads is the only thing you talk about (pointing at chapter president) you need to work that. We are all stuck in the mud. We know people that really need help that come to us for us to talk for them. You only help people that already have 2 or 3 cars but we know people that need help with housing. I have too much more to say.

Marjorie Johnson: Audit the MIP LeAnn was the only person that had access. Where the segregation of duties not only is the officials to be blames but the system need to be fixed. Marge is right. This chapter's Officials did not take the money. Like other places where there chapter officials do just that. It is factual that this goes back to the system. We are not involved in that Window Rock has to fix the more problem not here. When is the change doing to happen?

Chapter President: in February with the new officials we can come together and work on this.

Community Member: We need to talk to each other's with respect, love and companion, we need to work together. Get here prepared and post the meetings. Follow up that needs to be made on who will get help. We need to make it transparcy and accountability. Why is only one person to the MIP system?

Ken: Many issues some true and not quite. What's going on CAP policy and procedure not followed? The reports only 66 months Staff limited, 55,000.00 – 200,000.00 in 1 and have year that too much. Auditors are not attorneys does not investigate, criminal code should be next step investigation. When we apply for office we can't say we don't know, you lie to us, responsibility, you're supposed to follow rules, then you turn around and say you don't know rules, then it's up to us to push it. On most part we are on our way CAP.

Chapter President received emergency call and request to be excused.

Adella Begay: RDC met with New Mexico Chapter on extension of corrective action system. We don't know we want to know that happens, something needs to be done.

Mr. Jumbo: ASC to be assisting chapters, share suggestions with the AG. 90 days' time frame. Delegate sponsors legislation with protocol and moved to RDC who may recommend but does not approve. B&F final authority if not it goes before Nabi.
