3. OLD BUSINESS:

A. CLUPC Plan of Operation

The CLUPC Secretary recommended the CLUPC Plan of Operation be revised in response to questions regarding what constitutes a CLUPC Meeting. The Chapter Secretary denied payment of CLUPC stipends for the CLUPC sponsored Public Hearing on Dine' College Boundaries. The Secretary lacks authority to deny payment of CLUPC stipends.

A recommendation was made by the CLUPC Vice President to define meetings, as stated in businessdictionary.com as "formal or informal deliberative assembly of individuals called to debate certain issues and problems, and to take decisions. Formal meetings are held at definite times, at a definite place, and usually for a definite duration to follow an agreed upon agenda. B. Dine' College 25 Year Land Lease Proposal
The Dine' College 25 Year Land Lease was on the Tsaile/Wheatfield Chapter Meeting agenda for today's meeting that was rescheduled to next week.

CLUPC President stated she sent the resolution to the Chapter CAC. Discussion was held to revise the resolution to focus on the Dine' College boundaries only. A motion by Tomi White, seconded by Charles Chee to rescind the original resolution, motion passed by a vote of 4 in favor, 0 opposed and 1 abstention. The land considered for the High School can be reviewed when it is being planned and should not be a part of the land withdrawal for Dine' College.

A motion made by Marjorie Johnson to approve CLUPC 18-001 resolution as revised, seconded by Charles Chee. The motion passed by a vote of 4 in favor, 0 opposed and 1 abstention.

Additional discussion on the Class III environmental assessment confirmed the need to get a copy of the letter Lindsey Benally issued. It was also noted that Shiprock HPD is working with Dine' College. Marjorie Johnson volunteered to follow up with HPD tomorrow..
