Many years ago the school closed at Tsaile and now with the new building at the Tsaile junction.

 $Homebase\ was\ initiated-10\ students\ to\ start\ the\ class\ as\ need\ workers\ of\ a\ cook,\ bus\ driver.\ \ Teacher/Aid\ identified.$

15 students and looking at 20 children when all the teachers get situated.

In house advertisement open now.

Bus Driver in compliance with CDL, medical records required.

Union status for employee and that is why the inside advertisement is open.

It is fun to work with the children and incorporate the Navajo Language as the headstart strength.

Creative currilium. By law students have to be school readiness.

Salary will be implemented. We could have started this in February but now going into effect.

Ouestions:

- Invited the Head Start Staff to the chapter meeting or on a quarterly base.
- When do you foresee the 20 students
- Senior Center is intend to work with the Headstart to retain the Navajo Language –Interaction or events after school.

Extend his appreciation for the last term complete and have seen your work. Your plans for the work being spoken for is very important. Paper trail is most important for audit purpose. Many projects in the works now. Farm Board's work in the millions is yet to be seen this summer. Grazing Representative will have much to do. Navajo Nation Council winter session first thing to be addressed will be selection at 2years term. Nomination off the floor to be considered for the Speaker. Declaration of candidacy might be lost for the year. Johnny Naize has interest, as well as Kenneth Maryboy, on hearsay Lorenzo Bates, Johnathan Hail. We need a jail facility the one in Chinle has been condemn. Treaty of 1868 states to be protected by the public safety. Hearing process should be done on our trust land. Facilities started in Tuba City with opening in February 2013over 40million dollars. Crownpoint facility near completion to be open soon with 19million unspend and to be given to Chinle Agency. Design Dryon Murphy did the drawing with 3 buildings, Administration, Jail, Courts. Yet there is a proposal for 2 phases with a detention first. Budget & Finance Committee has been working on this. B&F informed the Chinle Officials years ago with land identification. March will be the ground breaking in Chinle. Other issue is the Window Rock Buildings of Administrations to be repaired. Gaming 5million dollars revenue. 30million loan for gaming. Purpose of gaming was to generate employment for our Dine people. There are 3 casinos in operation now on the Navajo Nation.

160million refinanced to 200million. Twin Arrows casino is near completion. 5million dollars given to the Navajo Nation and will plan on. The 5million will be distributed. Recent resolution from the chapter and the agency council requested equal distribution. Now the idea is uranium being speared by Albert Hale in the Churchrock, NM.
