- Substance abuse will this be covered, we have a lot of people with this situation maybe they need employment to be busy?
- RESP: the funds will allow the substance abuse to work with NCI. No hiring under the NCI.
- Funds are always only for a certain amount of time as 2 years or less. And that's it. These grants are good by it just ends at the end. We just get our people's hope up

and that is it. This Chapter is always willing to help so if need for assistance do not hesitate to ask.

- If an individual is test positive do you assist them?
- RESP: We notified the individual but it's up to the person to seek help. At times we have youth with this and we inform them to bring the parents if they have questions. But it gets very difficult.
- Comment: it only takes 15 minutes testing with immediate results. This type of hepatitis is through contact.

- January 25, 2016: There was a meeting at the Navajo Nation President's Office where they informed of the priorities.
- This is nothing new and it went to the CLUPC but we didn't get anything from them.
