FY2013 total UUFB \$30,274,679.00 – this amount already are wants by committees/chapters.

We need proposals ready for unmet needs. Five year plan and funds -

Tsaile/Wheatfields chapter established 10 year plan with priorities: Lake Development, Tsaile Development and Chapter tract and Irrigation at priority #10.

Proposals promoting: 1.7million dollars for irrigation this is different amount proposed. (Tabled for 30 days) Resolution supported by this chapter. CIO supported by legislation. 80,000.00 – Tsaile Development. 250,000.00 – Chapter tract.

What is now the plans of the chapter and maybe a need to reaffirm its resolution.

In addition, some chapters are requesting reoccurring funds for Grazing.

Navajo Nation Council Session....updated the Delegate charges with 12/11 votes to keep Speaker in status.

Question: Irrigation ranking LGSC recommends differently

Blackrock road was spoken of as a priority and when did the lake development become priority and the irrigation. We need to be kept informed.

Lake Development was provided by a conception plan. Chapter could assess fees for camping and rotunda.
