a) Dempsey Harvey, Acting Captain, Chinle Police District:

Officer was explained of a complaint that reached this chapter house and was supported by resolution as other chapters did. Yes a directive was order and this compliant was informed me by the chapter president and other people. The resulting of the his directive is a lot of misuse of the Navajo public safety vehicle. This directive was an in house only however an officer took copy and provided his father for spear heading this compliant. In one of the meetings the person that informed you came back and address he was sorry. I did ask him to come back to these chapter with me but not here. In taking back the take home vehicle it is saved in the month of February \$7,000 and for March estimating \$9,000. And will save quite a bit within a fiscal year we can save a lot and purchase needed items.

Questions/Comments/Recommendations:

Support the effort of non-assistance has been visible and is happy to report that this has taken place.

It was only a privilege of a take home (after hours with no record of showing that actual work has been done)

In the memorandum issued the take home vehicle was taken by directive was due to lack of funding. Is that correct? RESP: Reduce cost.

Navajo Nation does not know how to work together and results in this type of issues. In example the Fort Defiance 638. This chapter supported in requesting an audit by the people and then can be discussed. The concern is that in a situation of a community emergency what will happen? What type of services is to be provided? RESP: Yes your right and support the audit but not by the funds of the Chinle Police Department. In addition support the officers in doing their duties.

Gregory Tsosie, Officer for 20 years have polices and not in any supervisory position. In becoming an Officer we take oath and to do the best of duty, sign documents and to follow chain of command. The oath does not say the only way to do duties is by given a tribal vehicle for take home. There were only take home for the officers that were for substation assigned. Once a take home was assigned, Officers are to response to any emergency during that time. Policies are in place and it is known that Officers never respond to calls. If the Chapter Officials can

understand it would be good. Have not heard where Officers will come together and explained or address issues.

Questions/Comments/Recommendations:

Agree with what you said to serve and to protect is great. It would be great to get an officer back over here. There are areas where we need an officer close by. At times judges let go these criminals and that makes it seem like they do not care for the elderly.

In working with us as a Farming and to work with us is good. No wonder someone was very defensive.

There are very few Tribal employees that have a take home and hinder the services as same here in the chapter level. There are so many different entities and by titles with policies. You as a supervisor need to come here and inform. If we put trust in you then we will be able to work together and understand the policies in place. We as a chapter have assisted in Police saving.

RESP: Doing right goes along way. We can bring the officer that is located here to acknowledge here team effort to support this community safety. Yes, there has been many accidents where the officer here never responded.

In a collaborative effort of explaining is the only way to understand each other. There is a land in Tsaile where we can assist each other with establishing a substation there. We can also invite Apache County for assistance. Due to this incident we can view more areas.

The other area is a cell tower services for mostly emergency situation. Summarized the situation and recommend that

Chinle PD will be more than willing to assist. Youth need to be reminded. PD can bring officer to share a presentation. Mentoring the youth without technology is a thought and Chine has a Saving the Youth.

Senior Council is working on a meeting for the 10th.

Discussion on the youth is good and we have many head and really don't need presentation by the Shiprock and other areas. Some of you probably did not teach your children and we need to teach them when they are very small. Do not make it hard and we can do it.

Back in 1979 started one with a group that was very harsh. It can be done it seems as if our kids try to plan but we don't listen and we don't understand them. At our age we need someone to stand by us. We, as growing up were brought up very tough. If this youth group is developed again they can talk to each other. Now when you raise yourself it's child abuse.

We can restore hope in our children our youth. Your discussion and plans are welcomed.
