President James: Twin Arrows is slightly more expensive than the Albuquerque area.

Willis Becenti: Should the Division of Community Development be responsible for paying the entire cost, since they are the sponsoring agency.

President James: We continue to voice our concerns on matters of large Navajo conferences; additionally, there are no local areas to accommodate our large numbers.

3. 2018 Arizona Transportation Symposium – March 15-16, 2018 in Twin Arrows

President James: Presenting the agenda for the Transportation Symposium. Explanation of Direct Funding being handed over to the Navajo Nation.

February 12, 2018, furthermore, our Navajo Route 12 meeting with NDOT was proposed February 28, 2018, as the next meeting date – how is a \$36 million project not being communicated to the community stakeholders.

NDOT mentioned that the alternate routes have not been planned for when the highway is being constructed.

Willis Becenti: NDOT scheduled a meeting at Chinle (three months ago), and N12 was scheduled for 2020 completion.

Communication is a major problem for every Navajo Nation entity.

President James: Two phases in the N12 project (\$10 million each split), that was split-up funding, and caused a short delayed. The \$16 million project is another phase.

Delegate BeGaye:

1) Tom Chee, Rex Lee Jim, Dineh Benally, Russell Begay announced their candidacy for Navajo Nation President.

- 2) UUFB \$100 million was withdrawn for chapter use, where \$4.1 million will be given to delegates to distribute to their respective chapters. Tsaile Wheatfields Blackrock chapter has shovel ready projects that can redily be
- 3) Navajo Nation Drought Insurance: 2017, \$17 million was an insurance premium.
- 4) Grazing Officials are being forced to insure the laws of grazing capacity. Where Fish and Wildlife started to speak of reservation-wide Horse Hunting; and the Navajo Nation President ceased all activity on the Horse Hunting.
- 5) Ramah is receiving \$58 million from the Federal government; and Public Safety has asked for the \$58 million for all positions in Public Safety, and other delegates are proposing other uses.
- 6) Water Project: Ram Pasture and Blackrock communities in the chapter are ready, and only awaits for the funds to start the project.
- *Paula Begay*: Spearheading the collective chapters under Delegate BeGaye; and the revitalization of the Chooska Regional Council.

Recommending the projects for completion: cemetery, fencing the entire senior citizen center lot, etc.

Equal division is \$833k per chapter.

- Adella Begay: Potentially consider new chapter house during this disbursement of available funds.
- Delegate BeGaye: Siihasin is flexible, where CIP is under the appropriation act.

New chapter design should be done for consideration.

President James: Strongly encouraging for a more fair and equitable distribution of the \$100 million; suggesting the use of the 50/50 formula.

The strong consensus of Navajo public opinion states that the \$100 million is only an attempt for the current elected officials at the central government to have a favorable repour with the voters during an election year.

Delegate BeGaye: I represented our concerns and interests for equitable distribution.

Max Benally: Senior Center needs to have more representatives to attend the facility. This morning, there was only molded food being served; after the refrigeration has been out of order for more than three weeks.

The Senior Center Supervisor has asked that our leadership come by the Senior Center Supervisor, where the SCS is directly reporting to the chapter to inform the leadership.

Paula Begay: Supervision must be more proactive in strategic management and administration where the supervision should be more active in pursuing problem solving without stating the lack of chapter official and administration oversight.

Max Benally: The issue for communication is between NAAA and the delegate, where the chapter is not directly involved.

Willis Becenti: Bad management is consistent throughout the entire Navajo Nation.
