Senior Planner cannot conduct feasibility study but can assist.
 <u>Questions/Comments/Recommendations:</u> Borrow pit and gravel pit are different. Should a pit be feasible will the site only be for this chapter? RESP: NO it will be for the Navajo people. Votes: 43/00/09
- Reaffirming the Tsaile/Wheatifelds Veterans Officers Motion by Sarah James, second Billy Francis, Jr. David Tsosie explained and requested to support the Veterans for the Officers, Plan of Operation and the disbursement of the funds. - b. NTUA topic: Operation and Water Freeze No Show
- c. Council Delegate, Nelson S. Begaye; Sales Tax 3months NN 4million dollars and divided into Chinle 1million, into Tsaile/Wheatfields \$87,000.00 recent received. It is distributed by registration. Loan of 60million dollars for the Tuba City Jail facility with court system and again in Crownpoint. Chinle finally had its ground breaking which was very traditional.

N12 is not listed on the construction priority of safety project. 2.0 mile with the major area. 9 miles of Nazilni they can't even repair. Another meeting the BIA Regional Gallup office on March 27, 2013. Gaming issues NM agreement in 2001 Indian Gaming Compact and expiring soon. NGS Navajo Times reads it's been approved but it's not. Near Page the power plant is pushing for re contract for additional years. Many of you are mailing me to oppose re contract with Power Plants. \$680,000.00 was all NGS was paying without taxes. Now it is gone up to 9million with 6 owners. Taxes up to 33million for additional 43 years. Water basin is free to NGS. \$250,000.00 for scholarship yearly. \$180,000.00 to the effect area this agreement is pose by Salt River Station. 6people were identified by President Shelly without informing the Delegates until recent. This Thursday Salt River Project invited the Delegates for further discussion. Navajo Housing Authority get 90million yearly and unspent of 400million. Indian Community Block Grant only a few approved there was a proposal submitted on Horseshoe Canyon for power line extension and it was incomplete. The proposals needs to be done clearly as my Assistant started working on herself for the multipurpose building and she submitted in hopes we will be granted. The chapter staff and everyone just left for Flagstaff for the work session. Many chapters have started to follow our path in the stregtic planning. 72million dollars for the Veterans which is invested with interest earned and disbursed to Agency then to the chapters. The other funding is the Council Supplemental.

d. Indian Education Committee/Parent Advisory Committee: Johnson O'Mally funding supports the Buses and the Navajo Language cut at \$29,000.00 this will result in school closure. Tsaile Elementary School on spring break this week. A survey will be conducted to see if the schools will be recommended like the Fort Defiance Dine Bi'Olta. March 29, 2013 Tsaile Public School will host a parent conference its 4th year.
