II. REPORTS

- a. Henry Hank Haskie, Navajo Division of Health; I'm presenting the Veterans Wellness Initiative, relating to health, education & human services. I work with Veterans, on the NN Dept of Veterans Affairs, there is 10,003 Veterans, we have a lot of veterans. A lot of veterans are homeless, let's get the resources to the Navajo Nation, build a Veterans Center on the Navajo Nation. The NN Council approved the Resolution, start on the wellness and health care facilities for the Veterans, I'm just reporting the task that was assigned of the project. There is a need and for you to be aware of the request. It will be for the veterans and families, assist with balancing there checks, or go back to school, even learning how to cook, take care of yourself. Requesting support, if it comes to chapter in the resolution, it's the beginning of the project.
 - > Willis Becenti, Chinle has land available, construction to start in 2015, for a 65 unit facilities, you should work with them, and for housing, are you talking about the 2% set aside funds.
 - > Henry Haskie, Project is falling, it looks really good, there's no resources, no federal money, due to policies trying to get other funds. We are aware of the projects. They

have clients -80% is veterans -75% is from Chinle Agency, were thinking of Tsaile, because of Dine College, and the high level of technology in Tsaile, the beautification of the area, mountains and lakes, a healing place. We're focusing on Tsaile. When complete, we can use it as a model. We're pursuing for federal dollars and matching funds. All employees are veterans and doing it for 40 years. PSED no expertise, I don't want to miss the opportunity, of veterans facilities. Here is policies, the NN Council an advocate documents, there's no middle person, we can use this document, though this legislation.

- > William Begay, We are veterans, over 60 years, no one paid attention to us, finally now. We are notice, so many hours and listening to everyone, this resolution, were all different, with different issues, some veterans in hardship, but some of us, when we return, we had ceremonies done, loan available for veterans employed with NTUA, NHA and Navajo Nation, as payroll deduction. I live in a 30 years old trailer, they just look at our income, but we have other needs. I'm 64 years old.
- > Max Benally, at Friday Planning Meeting, it was recommended to CLUPC, what did they say? Any discussion or recommendation on the 10 Acres of land.
- > William Begay, every month we as veterans we request for assistance for appointment, if could have the facilities here, we could use the funds, for other things.
- > Henry Haskie, they just mentioned the 10 Acres and the Master Plan for the Senior Center Development.
- > Paula Begay, explained the land withdraw of the within the Tsaile Junction. The 10 Acre is rescinded back to land users and permittee of the area. The CLUPC recommended to re-assessment the development according to the Community Land Use Plan and revisit other areas of land with permit holders.
- > Henry Haskie, it's going to happen, here or elsewhere.
- > Willis Becenti, the land withdraw in Chinle, the land development for veterans, Wayne Claw is working on that project, get that plan done, just help them.
- > Henry Haskie, Whatever you decide, let us know in a form of a resolution.
- > George James Sr., thank you very much, land is very sacred, people don't want to give up land for development, we have to consider that.
- > Henry Haskie, think about the economic development, the employment for our children.
- > William Begay We're the biggest, there's no land, you comprise for land, here for the future, our kids, you see all this open land for development.
