2. REPORTS:

- A. CLUPc- Chair, Members: KEN was recognized by the VP, Davis to make his report. Ken reported on the recent mtg. that was to have been the Chuska Regional, but no quorum, and the additional meeting on Highway 12 reconstruction project. Ken informed, that the breath of the road project, from phase-1, branding corral section to Tsaile junction area just pass NHA housing.
