David Kedelty: The need for thorough report is important to discussion for future home owners, specifically for the current and in-process home-site lease petitions that are not consistent with the needs of the people.

Adella Begaye: Does the chapter have a policy regarding the approval of two opposing chapter resolutions?

President James: the question on opposing policies and resolutions is a made evident for the community to be aware of an opposing policies and resolutions that are left for the community to determine the final action.

Adella Begaye: Question, if the \$160.15 Catering/Purchase food for Chuska Regional Council Meeting on 4/25/17 is an allowable expense? And if it was approved by the community prior to expense?

Secretary/Treasurer Nata'ani: Prior to Chuska Regional Meeting, I opposed the use of the chapter funds to be utilized towards catering expense, and directed that such an expense cannot be authorized, because Navajo Nation policies do not allow for catering expenses per the fund restrictions. Emails were exchanged prior to the meeting date, to notify the chapter administration and officials to not expense the funds.

The day of the meeting, the catering purchases were made for the meeting.

Vice President Begay: Per the Navajo Nation laws, fund descriptions, and Appendix M, the catering purchase was not an allowable expense. I support Secretary/Treasurer Nata'ani's efforts to keep the chapter adherent and compliant when chapter funds are being expensed.

There is a loop-hole that exists in the expensing of chapter funds, where the expense is budgeted; however, for accountability and transparency, all expenses should be considered by the chapter community before any chapter funds are expensed.

The efforts to remain adherent and compliant to all accountability and transparency were part of my campaign, and the people voted to elect me to the position of Vice President to carry-out my duties and safeguard the peoples' monies and assets.

Paula S. Begay: Prior to the Chuska Regional Council Meeting, I was under the impression of prior administration to purchase for catering. During the time of the email exchanges, I was occupied with family funeral matters, and I did not view the emails till the day of the meeting. During the early morning of the meeting date, I purchased the food, and arrived to work for the meeting, it was then I read the emails.

My actions were in-line with Navajo customs of hospitality, that includes the offering of refreshments to guests, even if it just coffee. At the day of the meeting, I was asked if food would be available for the council, I replied that we are very 'stingy' here.

Directive within the Motion by Willis Becenti and Second by Angie Brown to include that all future outside chapter activities be approved before expenditures are completed for such expenditures. i.e. Agency Councils and Regional Councils. Vote: 17-0-11

Marie White: Traditional hospitality is customary for meetings and other events that require a meal preparation for chapter guests, and we show our appreciation for our chapter guests. That I encourage the use and adherence to Navajo philosophies and customs over non-Navajo philosophies and customs.

I strongly encourage the use of Navajo language in our official meetings.

Charlotte Begay: Fundamental Law from the time of Navajo emergence and the policies of the Auditor General are both used in our current state. In the Navajo Government Development process, we are experiencing the same topics for discussion as to which laws take precedence.

Allow for the CSC to be part of the communication, and utilized 'team-work,' for all chapter personnel and incumbents.

Adella Begay: The concern I addressed is not to withhold food, rather the undeniable

adherence and compliance to fund restrictions and Navajo Nations laws. All governments have laws governing allowable and disallowable expenses.

President James: Summary of chapter's expensing practices.

President James: Read revisions of the proposed, up-dated Tsaile-Wheatfields-Blackrock Chapter Housing Assistance policy, per the May 1, 2017 Planning Meeting work-session, for chapter community approval.

Willis Becenti: Are we able to use the funds for home-site lease clearance assistance?

Paula S Begay: Home-site Lease Clearance policy, if available in the chapter budget, modified budget for housing discretionary funds. We can create the funds.

President James: There are concerns for mixing separate funds and separate policies to expense chapter funds, that might border on disallowable expenses.

Paula Begay: Explanation of 2016 Home-site Lease information.

Charles Chee: Homestead explanation before the 1980s.

What was the reason for the creation of Home-site Leases? It was in regard to the marriages between Navajos and non-Navajos.

In 1969, I attended a meeting on Homestead, at this very chapter, I was the interpreter for my grandmother; 52 people agreed to the homestead.

I want to know the exact legality of the Homestead policy in regards to the 2016 Homesite Lease policy.

President James: Proposed Home-site Lease policy is amendable, and is able to consider all the suggestions from today's meeting.

Charles Chee: The funds for housing assistance must be regulated, to-date 72 home-site leases remain vacant since 2010.

Community members are constructing homes on areas that do not have any home-site lease.

Willis Becenti: Withdrew the addition for home-site lease clearance assistance in the chapter's proposed Housing Assistance policy.

Bennie Litson: Home-site Lease only allows you to have a home – without livestock or other construction. There are many unresolved issues in regards to the 2016 Home-site Lease.

President James: Reminds of the Housing Assistance Policy is amendable by the chapter community at any time, as the need arises for community members.

Max Benally: Policy needs to include the cap on minor (\$1.5k) and major repairs (\$3k).

President James: Cap on minor and major repairs will be added to the new Housing Assistance Policy.

6. Navajo Memorial Veterans Event donation - \$50

Wayne Claw: Supporting resolution to not allow any impediment in the construction of the Chinle senior citizen home, and to allow funds to continue for construction. The current politics of the Navajo Housing Authority is adversely affecting the pay-outs for the in-progress projects, i.e., architect fees are not being paid, and the vendor has discontinued further work on the project.

Willis Becenti: Supports the efforts of Wayne Claw.

President James: Modification of Resolution that Recommends to the new NHC Board to support the already allocated funds to the NNHI, Chinle, nursing home, where the resolution will not be hostile to Navajo Nation government offices.

President James: Assisted living programs are more beneficial to the Navajo people, where studies have shown that the overall health of our elderly citizens benefit greater autonomy, then our current arrangements for our elderly citizens.

Personal experience had a tremendous and emotional toll on the entire family.

Delegate Begay: At the end of May 2017, Navajo Nation government offices have started a process of discussions to address the needs of our elderly citizens to

December 22, 1993, Navajo Nation Council approved the Home-site Lease Policy, and Samuel Yazzie was the first motion for the 'then' Home-site Lease Policy.

Wayne Claw: Explained the process for current Navajo Nation elderly living homes.
