Major wash in the area of where people want with a need for a bridge and water crossing.

Range management area will take years to grow again.

There has been someone that gave consent to the Many Farms Chapter for work to start.

Mr. Bennie Litson: I am aware and know this road. It is true and a need for road improvement. In the first place the Many Farms started is good. But in the about 2 years I was approached and recall a public hearing that the District 11 agreed to keep within the original road. There are 16 people with permits on the north side and 17 permits on the south side. I have a Range Management Unit. I opposed the survey in my RMU when they were surveying. We wrote letters opposing this survey to the Gallup Office. They scheduled a field visit. There is another person opposing this effort. Therefore, we in District 11 oppose this effort in our area. District 10 can do what they want. Grazing members drafted resolution without consent. We will draft another resolution within the District 11 opposing.

David Kedelty: as an ARC this came before us last year only. ARC thought that the U.S. 191 and off that was being discussed. This is will not be constructed now. The next ARC meeting on May 9, at Lukachukai Chapter Meeting.

Zane James: Marco Sells recommends to host meeting with only the concern item with BIA. Also to compare the funding of cost. We will push this from the chapter area.

Marie White: As it is voiced we want the road to stay within the original area. Maybe there has been meetings scheduled but I was never informed. We have cattle within the grazing area.

Leonard Chee: Encouraged to fix this with consideration of Ki.
