Mr. Ray Gilmore: Little Colorado River has been discussed for the past 20 years. Only the little Colorado River. We have worked on this and gave back to the NN Council who has directed this project and now they want us to go back and inform the community. LCR approved 160acreas pre year. In prior years the NN Council approved and need to gather 2004 Arizona Water. Every 10 years their has got to be a monitoring of the water level for Navajo/Hopi. Introduced Technical Support and Chief Water Lawyer. Don't have the numbers of the wash flow amount but will submit later in the week.

Commits/Recommendations/Concern:

- A concern is the interpretation of footage of water for our elderly people. Our community has wants to erect the dams and other plans. Will this hinder and effect our plans in the future.
- Settlement Agreement Acre feet of water i.e. Home site lease or football 2500 gallons in 1feet. 325,000 per 1acrea. South of Navajo, New Mexico, this area is not effected as it is in upper base. Can you build dams? Yes over, under and on are Navajo. You are in the head and in control of building what you plan. Damming it up and capturing the water. Encourage the use of water. Surface water you can use you are not limited to amount. The settlement agreement does not affect you.
- We need to watch the upper Little Colorado plans for the future.
- Wash area we call the dried up wash how is that determined.
- Determination of surface water flowing through at what amount?
- Under ground water needs to be shared legally and technically.
- Will this report be specifically enough for the NN Council and to determine to say the Tsaile/Wheatfields chapter acknowledge.
- **The power point presentation is about 1hour with additional questions was not enough can be shared with the NN Council.
- A one day forum this summer would be good and not a true representation.
- What is the end day? Senator Kly has said Obama is looking at this as the most important and would like to go to congress while Senator Kly is still in office. At this time we are running out of time. NN needs to get this done by before June 20th.

 and provide a shovel ready project. You as Officials are the Leaders here. You need to follow these
 projects. As is NTUA is hindering our Tsaile project again. These projects will benefit many of our
 youth. Roads can be included in this project. What is the Chapter's Officials project and following.

us here that the Chapter. We have many things to do and say family is our priority but we work along our job.

The Police substation was designated at Tsaile but it never was planned. Katherine Benally does not want Group Homes only Housing in this plan.
