Senior Citizen Supervisor: Minnie Tsosie. Attached report which she elaborated on for the year 2012 and 2013. April 2013 served 460 people according to sign-in of services. Registered as new 150+ since moved to the new center. Serving 3 clients less then age 60 due to disability. Also provide health promotion with services from the clinic with exercising and etc. Also receive a sewing machine with only 2 people that has used it. Laundry services is limited to 2 times a week per person. Having transportation problem due to 1500 miles. This vehicle is only on a lease base. The other problem is getting people to come in and doing for the center. Very slow in getting participation. Encountering propane cost. To fill both tanks at 20% with propane is very expensive and was never informed. First delivery \$3,723.00 and about a month ago \$1,400.00 out of the \$5700.00. Nation's Gas was at less cost than Ferrell Gas. Need the chapter officials to think about this. NTUA has been sending in bills. As of this morning the State hired Max Benally 4 hours a day which is really needed. Need a male driver to assist. Elderly abuse is here of many kind. All cost is submitted to the State monthly for reimbursement. Care takers are not really taking care of the elderly. Care takers are to keep in contact with the Senior Citizen. Do not do special meals. Elderly are all different. You get to know people and it is really good.

Comments/Questions/Recommendation:

- Encourage the staff and really to go beyond to be proactive and to hear what the Elderly wants.
- What is the reimbursement rate for Navajo Nation? About \$3 for person. Where other areas get about 23.00 as the metropolitan areas. The other area is the eye check and making referrals. Took all the referrals to the office and was told no glasses for our clients. It was called from the central office in Window Rock. Requested for denial letter in black and white. To date, have not received anything in writing. June 23, 2013 combined Father's Day and Mother's Day with a prime rib dinner.
- Referrals gave the run around for mother and to get from the clinic and the clinic said go back to Minnie. Nothing done with running around. Picking up client is a run around and when call the Center I'm told it's up to Minnie. The former Driver was really good she use to go in and check on people.
- June Planning Meeting to direct a resolution for reimbursement and get Navajo Nation reimbursement vs. the State reimbursement.

• As former Senior Council Officers we worked with the Senior Supervisor, CSC, Chapter Officials and the Delegate. Now the chapter meeting sign-in sheet is blank. There will always be complaints but it is how things are done and people do not appreciate things.
