2. Horse Round-Up/Branding

We are late in the summer for branding Horse Round Up proposal with setting date and need your assistance. I will need 10 helpers at 15 days with CSC budgeted 120 hours at \$9,000.00 plus. 10 days advertise and notification. Possibly horse owner will house their horses again. July 29 to start which will be unknown to August 2, 2013. This horse round up will be in compliance with laws.

In September 5 days and 5 days in October with un-announced. Rangers indicated it is allowable. This will be stated in the resolution.

Stallion need to be useful and have a location on site. Cruelty to animals is covered. Risk Management will not allow castration. This will apply to donkeys.

 - i. Questions/Comments
 - 1. George James spoke of support for the round up. Too many horses in the Tsaile Area.
 - 2. Lorena Eldridge Supports the round up and there are policies in place prevening that.
 - 3. Thomas Litson position advertisement will be advertised and will advertise for positions for branding as well. Also, in reference to waivers and daily cash logs, there will be some fees and we are still working on that. As Charles Chee did and we will revist that. We will also accept donations for the workers as well.
 - 4. Danny Haskey in reference to horse round up, one horse keeps coming around my place. He ate my hay and later I roped him. I noticed he had a state brand, I thought state brands were only given in enclosed fields. Also, I've noticed a lot of horses with the same brand. I have horses but I keep them penned up. Also, I noticed horses with fresh brands, no one ever told me about a branding that took place. What about individuals who don't have permits but do have horses. Laws state that there should not be cruelity to animals and how will those be handled. Last week I mentioned that long ago people where given horses and they took upon those names, Blackhorse, Whitehorse and Bluehorse.
 - a. Response: Thomas Litson, you mentioned that you roped the horse and we need to be careful because if you rope another individuals horse and chase them, there is a penality for that. So if you will be in the horse round up, make sure you get that waiver in place. Those that have their own brands, it is not allowed. I have not really addressed that, my main priority now is overgrazing and round ups. State brands in reference to Navajos, you can request from the state and the state cannot deny that. Upon branding that animal, grazing official should be notified once the animal will be released to grazing. So state brands are allowed on the reservation.
 - b. David Kedelty The mule that is mentioned, he seems to be a hazard, I've seen him chase horse and the horses almost ran over some kids.
 - 5. Stanley Kedelty I have question and comment. Those horses that will not be released, where will they be taken? Is there any profit that will be made from those horses? Any profit in the past would be given to the Navajo Nation, is that still the case? Is there any possibility that any profits, can that be utilized for scholarships?
 - a. Thomas Litson that is what I mentioned, we will look at how the past officials conducted round ups. Additionally any profits to my understanding would go back to general funds if the chapter is not satisfied.
 - ii. MOTION PASSED: 34 in Favor 0 Opposed and 4 Abstained.

 - i. Denise, my mom moved back to Mummy Cave area. We have no utility connection to that area.
 - ii. MOTION PASSED: 32 in favor 0 opposed and 6 abstained.

 - a. Senior Center Fencing Project MOTION by Nelson James and 2nd by Sarah James
 - i. George James we were asked to sit on Local Senior Council, I'm not quite sure who our president is, we've only met twice. We have talked about why the center doesn't have any

decorations. They also asked about the funding for the facility. I spoke to my mom about the issue, there is a remaining balance of about \$5,000.00.

- 2. Nelson James this Local Senior Council to date has only met 2 or 3 times. In the meetings it was discussed that animals infringe upon the facility. We discussed the idea of temporary fencing around just the senior center facility.
- 3. Paula Begay \$5,000.00 balance for the facility was discussed with Minnie and she had mentioned the balance she would like to utilize for couches. The north side windows have been drawn on, vandalized to some extent. A chain link fence is not as expense and maybe we can fence off the facility. The whole acreage fencing right now is too expensive and we are still seeking funding. My son George asked a lot of questions in reference to the facility and what plans are in place for that.

- 5. Marie White in reference to the fencing, it is true and we did talk about it. However some of us didn't quite understand and some are old. My belief is to just fence off that facility for now as a temporary fix to avoid vandalism.
