1. Crop Inventory

Crop Inventory was discussed and Lorena explain what the crop inventory was and that all farmers whether they grew anything or not, they still need to submit the crop inventory. Lorena turned in the Quarterly Reports including the crop inventory. In the 3rd Quarter only 3 Farm Board had submitted their Form 2 and the Quarterly Reports. That was Ganado, Tsaile/Wheatfields, San Juan and Rock Point. At the last meeting Fred Jumbo gave a report from the WUA side as to who's field has been planted, but in Lower Wheatfields there are a lot of farmland that have the wrong names, and in Upper Wheatfields it is the same wrong names and Tsaile is the same, but the numbers from Lower Wheatfields is 25, Upper Wheatfields 12 and Tsaile 9. There are the numbers used in the Quarterly Report that was submitted for our Farm Board. We did pretty good for the first and second quarter and now same with the 3rd quarter. There was zero on the ALUP, the only one that still has not been completed is Sadie Neztsosie and Rafalita Benally, they have not turn in the completed application yet. Emerson gave a report that

increased the numbers of farms that have been planted. The quarterly report will be corrected according to this report. Emerson will be giving out crop inventory forms to the farmers since he is in contact with most of them then turn the forms back in at the next Farm Board meeting.

 - A. Project Status Update

Emerson Chee gave the report on the Wheatfields Agriculture Projects. He reported that the planted hay grazer for Sarah Descheene in Lower Wheatfields and Art Allen in Tsaile on July 20, 2018. For Upper Wheatfields they planted for Jim Ben which is the end field where David Tsosie's field is, then they opened the gates for Loren Davis and Ben Curley's fields. They also planted Taylor Allen's field. Water User Association worked with an individual from Water Quality from EPA that collected the names. For Tsaile they irrigated T-11, T-5, Samuel Yazzie, Freddie Yazzie, Fred Benally, Art Allen. The Farmers need to come in to update the names on the farmland. If it has been given to someone else, then the Farm Board needs to know. They also turned off the water about two weeks ago, there is a little bit of rain. WUA has been concentrating on Tsaile and Upper Wheatfields.

There is a reporter that came in to take a tour of the farmland in our area and he will be doing a study of the area, what the problems are positive and negative issues. He interviewed the Farm Board as the meeting was going. He had a lot of questions, but we had to keep going on our meeting. He will be going on a tour with Lorena and Lucinda after the meeting.
