3. Supporting the Canyon De Chelly Comprehensive Health Services, Inc. – P.L.93-638 Motion by Myron Tsosie, second by Leann Brown

Presented by Rosita Tsosie requesting support for work to continue for further next step to take. The other public hearing I talked about did not happen. Judge Tso at the last public hearing had a lot of questions and revise the resolution with reference items. He visited us one day and worked with him in Chinle. This will be approved by the Council Delegate. This resolution is asking the Health Board to pressure the 638 and the Navajo Nation is asking the same. We as a health board is different from the Navajo Nation. All the other chapters has support except this Chapter and Lukachukai-TABLED.

Questions/Comments:

- What happens if one or more chapter oppose? Will probably go back and strategize the plan.
- During the public hearing did not understand what was being discussed. Now are you asking separate from the Navajo Tribe and asking federal grants? You need to explain or even write and draw out for better understanding.
- What type of plans or you requesting for support, will this plan include another public hearing on the effort? Read the heading.
- The Indian Self-determination Act which we don't understanding?
- The revision of the resolution took place without our input as to benefiit only one person. We have insurance that is being discussed by the different parites. We don't know what the Tribes effort is? We don't even know what the Council Delegate will say. We also have heard that public hearing has been done and why to do another one but to support this effort.
- In the resolution being put forth needs your input.
- Why do you need other services for a public hearing? (meaning from Tuba City/Fort Defiance) NDOH –Tribe: want to contract as 638 (Public Health Nurse; Mental Health, Health Promoation, Enveniormental Health and the rest can wait) This means they become Tribal Employees Chinle Comprehensive Health Services want to contract All Services and the Health Board; (Chinle, Gallup, Shiprock, Crownpoint, Kayenta) with direct funding as 638.
- -I wanted Tuba City/Kayenta/Fort Defiance and other services to talk with as there were a lot of negative response. But if we can present at the next chapter meeting we can do this.
- This is a huge thing to take on and need proper planning to reach for and this is why we asked for another public hearing because we need assurance how our people will be treated and the insurance coverage portion. We need to be cleared on this and need all 3 areas to present at the same time. We don't collaborate/communicate.
- Viewed the 2 public hearing here and at the Lukachukai was too confusing. We need to have presentation in Navajo and not in English. It is true that some of us are concern and don't understand. Our concern has been the Tsaile Health Services with not providing adequate services. We need to all work together and not just a few weeks.
- We need to be presented by the pros and cons of this efforts.

Grazing Representative don't know where the funding amount is coming from we asked for a different amount. It will come to us rather we will do this or not.

Plan to have it 2 times; first to announce and the second time without notice or maybe a third one. Think about it yes maybe our President has veto it and he should be here this Saturday. 2 years ago he said he would help us. The grass is fried up and we need to do something with our over grazing. Tsaile the lake has lessen, Blackrock only on windmill working and what about the wildlife populations that needs to be addressed too. Maybe in a few more days we might encountered state of emergency. If the NN President can't declare the Chapter Officials can declare emergency. This amount will not take care of.

- Explain the \$22,000.00 with outlined budget
- Stretch the amount of proposing \$1,417.82
- Prior horse round up done, when this was done we did not speak of this amount. Plan was done with announcement in 3areas (Wheatfields/Tsaile/Blackrock). PEP funds used with number of position and requirements. Proposal to work with Dine College. Full record of date kept on file with the description of the horse, location to, amount expend on 10 days. We don't have to expend \$22,000.00 if we can all volunteer items, etc, but we can buy hay.
- \$22,000.00 was not about ready to be approved and ran 1 short. If no sponsor to this amount I support the effort of stretching the amount and go back to the original amount. Continuous resolution will need to occur. BIA has limited pens and horse trailer and will not do the round up but to haul.
- The amount is too high and a concern as the pens cost very high and the water troughs are expensive. Yes there are over grazing of horse and we only want things done for us. We need to consider cost saving and the need was to purchase a grader and what happen to that? We need to do cost saving for the future and what are we going to use. If this happens then you need to hire people that has not worked or need the job as they

Motioning parties withdraw their motions. Therefore it will go to the chapter house as an old business with the amount of \$22,000.00.

- With the master plan adopted wouldn't it be sufficient to fence the whole area or is this just to the senior citizen?
- It will require an RFP if it's for the whole 8 acres and considered as a project.
- In thinking about this when we say development it will require a nice fencing and not barbed wire fencing.
- It needs to be the whole 8 acres as the headstart fencing is only temporary and we can get quotes for the whole 7.89 acres, need to work at the whole 8acres.
- The whole acres as we have discussed during the ground breaking and reflect on it in the years to come. Nice fencing is what we want.
- Full mastered plan developed and not individually structure.
- Maybe the temporary lease can be extend through the nation in the mean time the plan is going for the whole development.
- At this junction site the other thing is there is no lighting and maybe this is why "kids" are breaking in. And at this time maybe we can discuss a name. The Elderly Home is being allocated funds with awaiting award letter. The idea of services to enter act the preschool, senior citizen and the elderly home.

- a. Council Delegate/Assistant: What matters most to the Chapter. Planning for students at the Dine' College housing; Gaming enterprises of 5million dollars for chapter to start think about how to be used with certain prevision. Also another 5million at the end of the year. President veto 2term to 4terms and clear language maybe he will veto or just sit on it. Kathrine Benally counter acting with Department of Natural Resources. To be in a meeting tomorrow with master plan and big plans and will advocate for Tsaile/Wheartfields Chapter. Delegate Begaye announced July 13, 2012 for T/W to host and on to Navajo into Window Rock for the session. Grazing, Farm Board and Veterans funds allocated. 3.7 million dollars for working areas and approved 2.8 which has been approved. Sent Amber to Denver 2.5 million dollars for Group Home which is allocated already. We are planning for babies to be born today. Bond Financing working on with some diffiucuties. Subleasing at the junction of Tsaile – met with Cross Roads a few times and interested in Bond Financing. But we are thinking about possible just developing the structure and lease. Chapter needs to get approved for the five management. Working on the FY2013 Budget. 173, this year 190million. Fuel revenues was projected at a higher cost but it has gone down a little with \$85.00 a barrel. Budget and Finance Committee meeting tomorrow. There is a proposal to recall the Navajo Nation President and Vice President due to miss use of funds and now paying back. The Council allocates 1.5 million for scholarship and proposal to increased to 10 million dollars.

- c. CSC- to allow for a brief report. Albuquerque Safety Conference attend on the staff safety and the building mold etc safety. Did not finish the conference due to family emergency of lost of sister-in law. And did not work for a week. Thankful for the assistance. Did not work 2 days Thursday and Friday as I attend the graduation of my step daughter who received her degree. Senior Citizen has a lot to do and the Farm Board has much work that they are doing.
