<u>1.</u> BIA

Herb Jones

- a. What needs to happen in order for the Farm Board and Water Users to work together is to reorganize at the central level. There has to be an Organizational Chart to show how everyone fits into the program to get the project done.
- b. Range Management Units, you have to work with the District Grazing Officials. There are disputes even in the Range Management Units.
- c. Title 3 and the CFR also has an outline of the position responsibilities.
- d. The Grazing Officials and the Farm Board Members have the authority to request for information to BIA.
- e. The Farm Board will work with the Water Users Association and request for information to BIA, without an organizational chart BIA cannot provide any information.

Elvira said that the Farm Board are the Technical Assistant to the Water Users Association, they had asked for assistance but are not getting any assistance. Maps that were provided to WUA are all out dated.

Lorena – Agrees with BIA and WUA. Our Plan of Operations indicates we oversee the ALUP. Money changes people which is what happened here. Once we got the money the organization changes and there was separation. How will we be able to work together to complete the project. There are 127 farmers and these people are the ones that we are to assist and that is how we got the funds. If the farmers would come to the meetings to give ideas that would help. The Farm Board were told to step back and we don't have a say over the funds, that is why we have not been helping the WUA and there is no drawdown. Shiprock has a Water Users Association and they work with the Farm Board very will, but they have an agreement between the two organizations and we are thinking this will help. Lorena say she thinks we need to do that and I am sure the 127 Farmers have a say in that too. We need to get together draft an agreement so we can all work together. We have not received any request for assistance from the WUA.

Anelda – says we need to put a work session together on Saturday and Sunday and she says the Farm Board are not helping them. The Farm Board are supposed to be the WUA technical assistance not the oversight to the WUA. Farm Board knows where the money is because they work with the Controller. She said the Farm Board are the ones that put the problems in place and the Farm Board are the problem. She was told by Lorena to lower her voice, she does not need to yell and Anelda said that is how she talks.

Elvira said the bottom line is the Farmers need to be here.

Anelda is saying that the Farmers are going to TJ Holgate with their problems and complaints.

Lorena said we need to come up with the agreement and we also need a motion on the BIA report as action items. Motion by Elvira Litson, and second by: Anelda Kedelty Votes: 9 - 0 - 2

There are a lot of land disputes, some don't respect the laws and don't abide by them. The Joint Farm Board are working on the process of canceling the permits. Roland Tso, Steven Kee and Tyrone Chee have cancelled some so they do have a process. There will be some funds for inventory. From our side, we want to work with the Farmers by helping them. We don't want to start cancelling permits. That would be the last option.
