1. Wheatfields Agriculture Projects

A. Project Status Update

On August 16, 2018 Lorena got a call on the invoices from Vangie Curley-Thomas, DNR and requesting for her to come to the meeting on the drawdown invoices and the modification, but she was not able to attend. She still got the information later that the WUA asked for 80,000.00 modification, but it was not feasible to do the modification. The problem with the invoice for the next drawdown is the performance report, they need to use the first draw performance report format, that way it will be consistent. Alvin Johnson was given all the information as to what he needs to do in order to get the next drawdown. This is the project status report. Meanwhile the over expenditure is just getting larger and they need to do corrections on that.

B. Fencing

The fencing project needs to finish. In the area of Kee Chee, Emerson Chee, the Benally and Danny John's fence needs to have a discussion, they were told to be at the meeting, but no one came in again. We will most likely move this to the next meeting. A letter still needs to be sent to Nelson James the illegal fencing.

The Farm Board talked about doing inventory of the farmland, this was discussed at the Joint Farm Board meeting. At our side we are not working on cancelation, but working with the farmers to revitalize the land. We have 33 ALUP in Lower Wheatfields, there is 53 for Upper Wheatfields, and Tsaile we have 42 ALUP. We don't cover dryland that is under the grazing. Alden Begay said he is part of Upper Wheatfields and would like to start working on the field. He wants to know how long it would take to do the inventory. In Lower Wheatfields the average is 16 to 21 acres and there is one that is 2 acres. We have to find out who the farmers are for each farmland, this is what we are referring to as inventory. We need to find out which are probate and if you give the land to someone then you have to have a conservation plan. It took Lorena 3 years to get all the farmers to each land in lower Wheatfields. Lorena and Lucinda will be starting the inventory for Upper Wheatfields on September 2, 2018 at 8:00 Motion to accept the report and to have Lorena and Lucinda start the inventory: Motion by: Teresa Chee
