Operating budget 325,000.00 by LGSC, 160,000.00 by legislation with supplemental funds coming. Comments:

Extend appreciation to Council Delegates. Meeting budget to increased to \$300.00 per meeting for each delegate who views this 3times. Audit was extended and the legislative staff was increased. Executive has not received any raises. No one reviews the legislative oversight. There has to be a way to have equity. Legislative need to review Mark Grant's recommendation for transpierce.
