We talk and say we need water however we don't preserve our water as of this past summer rain. The plans and documents of water usage is a need. We need to know the amount and the water table within our community. Support the travel request.
- Water rights really worked on it we and the need of our community. Down south they tribes really use and resale the water. We have to really identify how the water is used here.
- Information of idea and conference learned is brought back to our people with report.
- Water shed study toured the Chuska Mountain. Finding was that when roads are implemented for whatever the project and when that ends there is no reseeding.

- Upper Wheatfields in the Litson area has not been addressed yet. There are a lot of no brands. And of course there are complaints. No brand horses can be branded after 10 days old to 6 months. You can manage any livestock. People do not have respect for anything.
- There are a lot of horses roaming near homes.
- Horses have traditional stories from its hoofs up to the eyes. The horse round up is due to the land. There are people that know how to manage horses.
- Need educational presentation for community not just the round up.
- Include in the resolution the need for educational awareness. Some advocate for the livestock in the lively hood of one. How can we teach each other the support of resolutions. A need of a document camera to view the resolution.
- There are no funds for education
