Concerns/Questions/Recommendations:

- Keep at 25 due to acknowledge and participation with encouragement within our family. If increased to 50 would be a problem. We can blame the elected people but it is the people that make the discussions and support.
- Issues that need support for improvement of community projects, or is that we don't support the Officials maybe we did not vote them in? or are we the community people the problem. Many things that are in the works would not have happen if it was not a chapter meeting item. Many of our regular chapter people are now encountering health problems.
- We need to discuss this issue and to work with respect. The 15 quorum count is good. If you respect your elected official(s) you should be here to support early. As a young elected person you cannot assume that we know the whole Government. During acceptance of scholarship application we should have power point presentation as many the youth will sit and question what the motions or votes are for. If the consistence is to keep at 25 them we put on the time wait only at 45minutes then to cancel or reschedule. Have respect both ways.
- Revise the sign-in sheet to add the other elected officials and chapter resources.
- To start the meeting with 18 members was discussed also. As recommending at 25 is good. Votes are held high and honored.
- Back in the 70's when vehicles were limited this chapter never had problem with making quorum. We need to educate ourselves as it looks to remain at 25 quorum count. We need to agree on wait time.
- At the Window Rock level it is with honor and leverage with high counts of votes to our chapter documents. Recommendation to announce the chapter agenda with technology for off reservation comments. Written report is really not necessary as we have our elderly who want verbal reports and to keep quorum number at 25.
- The recommendation of 25 quorum with adding chapter resources/committee with time of arrival. The other issue is food but only a few donate. The quorum status has been discussed during different chapter administration.
- One concern is that we start the meeting too early and should start at maybe at 12:00PM or 1:00PM. Sign-in sheet with recommended blanket lines for chapter resources to determine who arrives.

Establish a region policy for growers and policy issue to start getting natural grown food into schools and markets. Proposal will cover \$4,000.00 each year if awarded of 1.2million for 4 communities. Involving the community is very important.

The training schedule location at the Chinle will be January 23-24 for the Delegate and Chapter President with January 20th at Lukachukai Chapter House public hearing you are welcome as announcement:
- f. Council Delegate: Nelson S. Begaye will be going to Lukachukai Chapter for meeting that is in process. January 16th, the Waterflow casino will open. 30million dollars to loan to open this casino. Twin Arrows will be opening within the year. We have much saving into banks and maybe plan to open our own in the future. Veterans at the chapter level unspent funds will be included with the agency funds as re-distribution. Current this chapter has 39 male and 6 female veterans recorded. Scholarship receipt ants are large here and next spring scholarship amount is not passed by congress yet totaling at 6million. The Window Rock office has only forward letters to the students. Roads FET of .18 is a concern and yet the roads are not fixed. Met with the Navajo DOT, County and BIA. Parking lot paving project was awarded in 2004 but not done yet. BIA Harold Riley with concern to work on the major thoroughfare. Blackrock road is scheduled within the next 5 years. Casino monies of 6.4 million from road funds. Budget and Finance Committee voiced to obtain all unused funds. There are funds in Force Account. Bond Financing at Tsaile Junction with 1.3million to develop and Edison at \$600,000.00 but lacking approval for business site lease.
- g. Community Service Coordinator: Paula S. Begay reported on behalf of the police regarding the Toys and Tots. Staff assisted in the remote areas with some coming to the chapter for toys. Met with the Rural Addressing and CLUPC with training. Albuquerque end of the year reporting due to family ceremonial and did not attend the training. Land Corporation with Senior Citizen on interior fixtures of floor color. Regional Four Council meeting with collaboration of CSC as we will work with the Council Delegate. Cell tower by NTUA is doing this within their ROW network wireless. Here north of the chapter should receive services.
