3. Supporting Cellular One to construct tower with a corridor (land withdrawal) Motion by Nelson James, second by Max Benally

Deswood Begay, Representative update of 2012 for additional towers and the need by request of Wheatfields area. This plan is of 2007 to date for a cellular one tower. North of this chapter house NTUA had designated a site but did not go in place. But Cellular One Managers decided to continue with the tower due to emergency need We would like to construct before 2014.

### **Questions/Comments/Recommendations:**

- Grazing Representative still need 1 consent. Now, to do is field clearance and no concern on behalf of the grazing representative. Then process is Grazing will review and sign.
- The site where is it and will it really help the valley?
- RESP: near the Jordon River Church and will help this area with another one in Chinle to assist Blackrock area.
- What would be the next process?
- RESP: Once the consent is done, survey will be by Cellular One at our cost, EA, Arch, ROW, within one mile radius. Thereafter the NN Land Department with HPD, NEPA, DOJ and others to obtain the final document. It will take about 8-9 months to start construction. The actual tower construction is only 3 weeks; hook up with electricity will be alone the process.
- Honorable Delegate and his Assistant will provide their assistance with the process.

### **Questions/Comments/Recommendations:**

- This will only be a flat blade with no major improvements. The Blackrock community has about 9 elderly and biggest need for road improvement. This route is a major bus route where the bus is always getting stuck.
- We all want our roads improved and to keep Lower Wheatfields as bus route.
- Recommendation:
  - -3 miles 8084 Ram Pasture Road
  - -3 miles 8077 South of Dine College towards Blackrock area
  - -3 miles 8079 South of Chapter House towards Lower Wheatfields
  - -3 miles 8080 Whitecone to Upper Wheatfields
  - -3 miles 8089 Bear Springs Road off 8077 west of Blackrock Canyon
  - -Total: 15 miles
- Is it feasible to take BIA routes and assign to County or Navajo DOT for services.
- According to the last Road meeting, Apache County Kirk Arviso said say not feasible
- What is the plan of the chapter's for a grader as Navajo DOT is limited to 15miles and the County is only maintaining their routes.
- Empire \$340,000.00 and we have already invested about \$20,000.00. Where are we to get the funds and where. Delegate will meet with the President and see what can be done.
- CSC during our roads meeting BIA's priority is the N12, County's priority C320 of 3.7 miles of gravel on Blackrock road and the Navajo DOT with the 15miles.

#### III. REPORTS: Motion by Lorena Eldridge and Frank Begay, 2nd

1. Indian Education Rep/Parent Advisory Committee

Nelson Claw presented on the Chinle Unified School District information of Navajo Language within the studies of Kg to 6<sup>th</sup> graders survey. Survey shows that kids really cannot carry on a conversation in Navajo. He also shared a concept of the Navajo history orgain the school has developed but no in the classroom yet. From a previous meeting, there was a misunderstanding presented from cuts in Federal Funding. There was conception that budget cuts would affect bus routes. From Chinle Schools, budget cuts will not affect our work and we will continue to work for the next 4-5 years. Budget cuts will not effect CUSD, at the district the Business Manager, various funding came from various areas. Business Manager invested and put away funding for future and that is what will sustain the district. Will not reduce bus routes, will not lay off staff and the individual is Quincy Natay, son if the late Ed Natay. Just recently got 10 new buses, tsaile elementary has a new school, wildcat den is paid for, he was very effective in planning for our future.

Work with at risk kids, kids with no home, less fortunate and single parents or no parents. We do have kids like that in our community, with that said, help the kids that are in those situations. During Thanksgiving kids were asked what they were thankful for, more then half those kids were thankful for animals, horses, sheep, dogs, etc. You would think kids would draw their parents but majority drew animals.

During Christmas kids were asked the same thing, what do you want for Christmas? More then half the kids said they wanted a Dad. Are they telling us something.

- 2. Community Service Coordinator
  - a. Paula Begay Thank you for the food. 2 weeks ago there was Public Hearing in Low Mountain and the topic was federal funding. Local senior centers brought their staff, people were allocated 3 minutes to talk. Service provided to seniors was something that was voiced. My main reason for going was to advocate for our new center. Some of the things I brought were the staffing, we need more staff. Also the operation and maintenance for facilities. Both Max Benally, Rita Jishie and Minnie Tsosie all spoke. All those voiced concerns were documented and will be sent to the state of Arizona.
  - b. From a Roads standpoint, when we rented that grader, we got what was available and the high tech grader was basically assigned to us. Some areas were really assisted by the grader, there are some areas that are still frozen and muddy. Price quote was given to us for the grader, it was quoted at \$340,000.00 Some homes are still not assisted, additionally we are getting requests for home site cleaning, weddings, clearing ceremonial grounds, etc.
  - c. They also had a public hearing at Dine' College on certified chapters and the problems they encountered. Upon certification, chapters assume all payroll responsibilities, such as insurance programs and others.
  - d. The chapter website is <u>tsaile@navajochapters.org</u> and we are planning for summer activities. Black Rock residents stressed the need from water line issues, resolutions were forwarded to OEH and they will do an assessment. Some applications were hand delivered and those will all be combined.
  - e. Electrical line request, NTUA is stressing the need for Mobil Homes to live there at least 9 months and need a homesite lease. They will be having a public hearing on 25<sup>th</sup>, the Browns have moved back they want these services.
- 3. Council Delegate
  - a. Nelson gave report on recent council session.

- b. Also gave the floor to Mr. Leonard Teller.
- 4. Chapter Resources
  - a. Farm Board Lorena Eldridge restressed the chapter Farm Board membership. Also introduced the Water Users Association. Our main focus is Land Use Permits. That is the main of our discussions at farm board meetings. In April residents will be getting invoices for annual invoicing. Wheatfields Lake draining will happen on May 9<sup>th</sup> for lower Wheatfields irrigation purposes. Upper Wheatfields will happen around the same time. Please get ready for that. Farm Board was going to submit for grant with Water Users under First Nations, 5 farmers were identified to work with the youth. Funds were earmarked for seed purchase. We are also working on a logo for the Water Users Association.
    - II. Questions: Pearl White asked how many individuals were funded for these projects. This grant, exactly how does it work? Is it on an individual basis or for the whole community. There are 42 fields in Tsaile, 128 fields combined. How many acres, 570 acres in Tsaile, 643 acres in Upper Wheatfields and 465 acres in lower. All together there is 42 farmers in Tsaile, 52 in Upper and we are not sure on some residents correct address. The funding is only for \$10,000.00, not much. The funding is for land use permit and farmers that are not cultivating. We have until 2015 to have at least half of all the lands being utilized. One is for an individual to attend a 1<sup>st</sup> nations conference, \$1000, stipend for 5 farmers, whoever wants to for \$2000 and consultant to assist for \$500.00. One for home visitor and take statictics or survey assessment, an individual for organic farming. 5 farmers are Freddy Yazzie, Kathy Johns, Danny Johns wife, Patricia Johnson and Merle Kedelty.
  - b. CLUPC Cindy Davis, we have been working on rural addressing and ready to finalize. Our CLUPC is certified and at that time, the manual was outlined and we are revising that. We are have a work session and revise the manual on the 25<sup>th</sup>. The 2<sup>nd</sup> Sunday of each month is our set date for meeting.
  - c. Grazing Thomas Litson mentioned the Water Users plan of operation and it references ALL water users so it indirectly involves me as well. On May 6<sup>th</sup>, we will meet with Farm Boards to address non farm users. There is growing voice of lack of water for farming, we are not working to well with Navajo Nation Agriculture and looking at set aside funding. On May 2<sup>nd</sup>, NRCS will be here to meet with us.
  - d. CHR Alta Begay reported that she had some announcements. 2 things at the end of April 30 and May 1 for 1<sup>st</sup> responders. After that we are working with Teec Nos Pos people who work with diabetes, will be a training, but only tentative right now. If you are trying to get a hold of me, call the chapter, leave a message with Leanna. Immunization is one of our major things, we had pertusis case in Tsaile so we really request everyone to get them immunization. We have to have 15 different shots that we should have. Local kids have had high rise in head lice. Severe case is not in our community so we are grateful. Over the counter meds for lice are becoming ineffective. Produce was selling in chinle this past week. We really need to get our ALERT team reorganized and need it for certification for the chapter. Other question I have is for Zane, Chapter bought me a computer, printer. I buy my own cartage and who will maintain that computer, since it is under the chapter.

  - e. Max Benally indicated that they advised the local senior council that they need to be involved in chapter planning and meetings. There are a lot of people out there that need help. According to the charts that were handed out at the NAAA meeting and we are at the bottom. Those charts however are not reflective of the current operations.
