2. Request for Timber Sale on Blackrock Community Road – Apache County Road 320

Herbert Clark: Along the Apache County Road 320, there is a dire need to fix the road to ensure safety – requiring a Timber Sale.

3. Supporting Resolution Green House Tunnel567zv

Dorthea Litson: Proposal with First Nations \$40K to cover the cost of other establishing tribal plant nursery, in partnership with tribal office.

Proposal requires crop and vegetable growth, where the Green House Tunnel will start the pre-planting during the late winter, therefore transplanted in the spring.

It will require a space of 20' x 40', at least two Green House Tunnels, for our purposes, that complies with NRC standards.
