Proposal requesting for Farm Equipment and Personnel Lorena explained that the Farm Board and Water Users submitted a proposal to Navajo Nation Department for Agriculture for the Narbona Growth Funds. Plus we need to revisit equipment listing and maybe add additional materials needed such as fence for perimeter farmland fencing.

Please note: We end up talking about Wildlife problem and requested to see if a farmer can attend GIS conference.

b. Underground Irrigation Extension in Felicita Bahe's Farmland, Lower Wheatfields

Felicita Bahe requested to amend the agenda, and add her concern to it. Lorena asked the motion parties who accepted the agenda. The motioning parties approved to add to agenda.

Felicita explained that she is aware that at the time when the irrigation was being installed in Lower Wheatfields each farmers were asked to take part in the design of the irrigation system that exist within their farmland, but she never bothered to say anything. However, she commented that she currently have two alfalfa raisers in her field, and the last one at top does not have enough pressure to irrigate her entire farmland. She wants that last raiser move about 100ft or less so they are able to irrigate to the east side of her fields.

Questions, comments, and suggestions:

Dorthea commented that I am sure the Water User can work with you do some if it does not have any water pressure. You (the farmer) will more like to be asked to purchase the pipes needed to make the extension while the Water user find the equipment and labor to extend the line.

James B. commented that it is impossible for that raiser to have no pressure. Each line has a lot of pressure.

Lorena asked if they are using the gated pipes to irrigate.

Mr. Bahe explained that the gated irrigation pipe is NOT use. It an open irrigation ditch and there is an areas of the open irrigation ditch that cannot serve the water.

Lorena explained that as farmer we need to move forward to improving. The system is developed to gate irrigation pipes.

Dorthea explained that Kim Martinez, Basin Pump owner, know the design of the irrigation system. She is willing to work with farmers when purchasing their gated irrigation pipe. Dorthea commented farmers to purchase the 6" gated irrigation pipe. It is easier to handle and munch lighter than the 8" gated irrigation pipe.

Action: The Water Masters can set up the gated irrigation pipe without the \$70.00 rental fee. Felicita will use gated irrigation pipe to experience if water is able to be utilized for irrigating where she unable to get water to section of her farmland. Based on the experiment then Water Users can move forth with her request.
