1. Crop Inventory

Lorena did not send any crop inventory forms to the Chapter, but she will bring some on Tuesday. Crop inventory is one of the forms that is required for a permit. We as Farm Board have to submit these forms every quarter although we are only required to submit twice a year, we continue to collect these forms throughout the year. This will just be a report. <u>Goal Statement:</u> Conduct 2 agricultural educational outreach/workshops for farmers per guarter per 13 FBs.

1. Wheatfields

Emerson usually give this report but he has not come in yet, we don't have a report. Emerson gives us a report since we do not get reports from the Water Users. Irrigation is a problem. Lorena asked for water in June, but did not get water until August. The water was going into the pipes at the dam, but nothing at Lorena's and did not know who was using. The irrigation schedule was better last year. This will be part of the nest report. We should meter each farmer; I think that will give us a report as to how much water each farmer is using. We would also like to have a copy of the irrigation schedule. Aaron is using the water again, he cut his hay and now irrigating again while everyone else is just waiting. Sadie is also irrigating.

<u>Goal Statement:</u> With farmer participation, Implement conservation training and develop 2 or more plans per quarter per FB review.

1. Training

8/27/2019 is the Permittee Meeting at 2:00 pm, this is training for the Farmers and Ranchers. We asked Fish and Wildlife to be here, but they are part of the Fair so they might not be here. This is part of our budget to give training each month, but we don't know what our budget looks like for next year. We are not in compliance because our Vice President has been missing a lot of meetings.

Dine College usually puts on training for the Farmers also, and this is with the Water Users. Daniel Staley also brought up irrigation in Black Rock area. There are farms there but no water. Is it possible to bring water from Tsaile Lake to Blackrock. Lorena just said there are all kinds of possibilities. The whole purpose of this funding we got was to revitalize all the farm land and plant on them for two years, then we can ask for funding to repair and upgrade the irrigation system for Upper and Tsaile areas, but there is only 20 to 30 percent production. Dryland farms are part of the grazing, which is Blackrock. The Farm Board only take care of the Upper, Lower and Tsaile.

 Agreement with Marquel Begay Marquel wanted to help the Farm Board with the Farm Plots in all three areas, and she said she finished Lower and part of Upper Wheatfields and nothing in Tsaile, but we have not seen a report yet. She is working with U of A and working on the Water Shed in Whiskey Creek, Wheatfields and Tsaile Creek. We will not be putting her on the Agenda again, if she really wanted to go forward with this she should have been here.

Lorena explained that there is Grazing, the Farm Board and the Chapter and they all have different duties. Jessie was not sure which to go to so Lorena had to explain. Right now, any transfers that have been submitted, Fish and Wildlife is the hold up. There is Permittee Meeting in September where we will have more information on this.

There is also talk about the General Leasing Act, RDC and Land Department met on this in Albuquerque.

Lula Kenny also found her permit, now they will be waiting for re-survey since part of it has housing on it.
