- Concern, as to how a council delegate's loyalty is strained between the Navajo Nation and a State County government.

M. Johnson: Questioned the reasons of the Council for approving the President's Executive FY17 budget, which is an increase-double the amount for the budget, while programs that provide direct services to president's four pillar priorities were slashed. Oh

K. Johns: Expressed a sincere distress on how Navajo senior citizens are being forgotten, and they are alone with little to no- resources; while the Navajo Nation government officials are hoarding Navajo Nation monies for their personal benefit and gain.

#### 4. NEW BUSINESS

# A. Farm Board Report

Lorena Eldridge, Farm Board and Water Users Association: FB and WUA received seed-money from First Nations and has grown to receive Sihasiin Funds

There are127 farm plots in the TWB Chapter, in conjunction with the land-use permit holders, the permit holders are able farm the land. There are very few areas of success. Earlier this year, FB/WUA contracted the services of James Peshlakai to conduct a workshop on traditional land use

Navajo Nation Conference held at Twin Arrows – TWB FB/WUA submitted a proposal for Sihasiin Funds, \$3.2 million original, after much advocating, TWB FB/WUA received \$5 million for the Wheatfields Area Project - Agriculture, starting from 2016, the council delegates focused on shovel ready projects, Year 2 and Year 5, Fund management plan has been a project, September 14, 2016 – B&F presentation,

Delegate Seth Damon, B&F Committee received fund management plan. Met with OMB, at the second meeting with OMB, including the Division of Natural Resources and council delegates. It was determined that the lead for the Wheatfields Area Project – Agriculture will be Agriculture Department, and an agreement continues to remain moot, potentially, Water Management Branch will most likely be the lead.

The grey building and orange barn on the Chapter land might be available. There are areas of concern that do not seem feasible, so the movement is towards another plan.

With the fund management plan, there is a plan to create a warehouse to house potential materials and equipment with the Wheatfields Area Project - Agriculture.

In regards to the Master Plan for the chapter, however there is a 2010 lease agreement, 11/22/95 a lease was given for Apache County; was not to exceed 20 years.

Efforts to contact Tom White have not been successful, and there is language in the lease that states whatever has been created on the lease, will belong to the chapter.

An inter-governmental agreement does exist, however, the IGA was never signed, except by David Kedelty. The inter-governmental agreement has never been fully assigned.

Lucinda: The particular nature of lease agreement is moot. Additionally, there is no master plan for the chapter house land area-plot.

Marjorie: If the master plan was never addressed, it is within CLUPC to produce the Master Plan.

Lorena: TWB FB/WUA has a Plan B: Beige building.

K. Johns: (Comment) Keep on top of things, particularly on areas of staying up-to-date. Is certain that there was a mentioning of Master Plan.

Devon: At the time, in regards for office use with WIC, it was stated that the chapter owns that property.

Marjorie: Copy of the lease for review requested from Paula.

K. Johns: Would like to support Mr. White if he wishes to re-new the lease.

Delegate Begay: \$5 million, it is crucial to get the property for Farm Board to move forward quickly, and to allocate the land.

K. Nata'ani: Request DOJ to review lease agreement and determine if DOJ will re-affirm their earlier decision.

M. Johnson: Inter-Governmental Agreement would be the easier step, ask FB/WUA to draft an IGA for consideration in regards to the beige building and land plot; where WUA is the holder of the 501-c312, and FB works in conjunction with WUA.

# Motion to accept report by M. Johnson to, second by Vice President K. Johns. Vote: 7 in favor, 0 opposed, 1 abstain.

Motion to accept report and approve a resolution by M. Johnson for the chapter to request Apache County renew lease for continued occupancy within the chapter, second by Vice President K. Johns. Vote: 7 in favor, 0 opposed, 1 abstain.

Johnson to request Chapter FB/WUA to develop an Inter-Governmental Agreement to request land withdrawal with the chapter boundaries and existing warehouse, and accept the New Business, second by Vice President K.
