1. Wheatfields Agriculture Projects

A. Project Status Update

There was a Budget & Finance meeting on the 13th, but according to Robert Willie the report was only about 5 minutes, it was just Aaron and the group there, but there was not really any discussion because Vangie Curley-Thomas did not show. Lorena did not attend either, but later afterwards Lorena talked with Vangie and according to her there is still a lot of problems with the invoices and expenditure report so there is still no drawdown. The auditor general is still doing the audit and they are looking at how this became a family business. According to Emerson, this might be his last week because there is no money. Right now he is just disking what was planted back into the ground. He is working on Tsaile right now. Some of the people still have some grass and looking for someone to put their cattle in for a while, but people will have to pay. Daniel Davis asked about land leveling, what the cost is, is it by the hour or by the acres. When does the charge start, when the equipment leaves the yard, or when it comes into the farmland. He had several questions on the project and on the equipment since he has operated large equipment and worked on large farms in Colorado.

Fencing is not complete, when Emerson finishes his work, then he can start working on the fencing. He just needs a welder to complete the fencing, we need to finish the fencing soon. Antoinette Deswood wants to have her gate up, but one area she has the fence open that has not been done.

B. IAC Conference

Lorena is the only one that will be attending the IAC Conference. The Chapter does not have any money to assist with.

C. Joint Meeting – Farm Board, Water Users Association Board, Grazing, Chapter Official/Personnel and Council Delegate will need to meet as soon as possible to get the project back in order.

This will be to discuss the 5 options that Dana Barboff recommended.

- 1. Rescind the appropriation/amend the original legislation
- 2. Transition to Department of Agriculture
- 3. New agreement Amend the MOA
- 4. Transition from DNR to DED through the Farm Board w/agriculture expert
- 5. Turn into a grant, run through the Navajo Nation & Non Profit

This is what the attorney said at the meeting to solve the problem. Lorena is for number three of the option which is to amend the Memorandum of Agreement and develop a tri-agreement with the Farm Board, Navajo Nation and Water User Association. We will talk about this at the meeting and come to an agreement, that way we can get the draw down for this project. The meeting will be on December 5, 2018 at 2:00 pm
