The main problem is there is no water so we cannot really push people to farm. Everyone will say there is no water so why do you want me to relinquish the land.

Why did the farmers not go out to farm, is it because of the WUA? Or do people just want someone to work the field for them.

Emerson said he has been calling Paul Long, Jr. to see if they can open the gate back into the Lake, but no one has come out yet. Most of the water is going into the lake now and some of the water is going down the stream. The gate valve is stripped but Emerson opened it back up. We need to accept this report.
