President James: Presenting ITG training information, strongly recommends safe travel, and travel expenses reflect for three days of official travel (two nights).

*Paula Begay*: Explaining the history of MIP where the Navajo Nation Central government by-passed the procurement process, championed by Rita Largo, and all 106 chapters passed supporting resolutions.

ITG-MIP accounting software is vital to chapter administration.

Paula Begay: Strongly encourages Chapter AMS to attend the training to maintain efficient chapter administration.

7. Supporting Resolution to Apache County Road 4040 - 1 mile

Frank Kedelty: Under the previous Apache County administration, the roads were mildly maintained, compared to the current state of rare maintenance.

Requests for Chapter Resolution to start the process, currently only the gravel on the bus route is the obligation of the county, road beyond busroute is not allowable for maintenance.

Recently, the bus ran-off the County Road, and we intervened to assist. There are three middle school students, and three high school students from Chinle.

- Lorena Eldridge: Comment BIA roads and older roads need to be taken care of in addition to the county road in the discussion.
- President James: Encourages chapter officials to provide solutions that require extreme critical thought and creativity that aim to solve our chapter needs.
- *NHA lady*: Encourages for all the leadership to come together to make aggregate decision making.
- Delegate BeGaye: Legislative efforts to secure funding for roads is attempted but at the mercy of the voting council and committees
- President James: Transportation priorities to conduct in the best interest of the community, to place a priority on the roads.

\*\*\*\*\*Rose\*\*\*\*\*Requesting on behalf of 43 year-old daughter – seeking assistance for medical bill \$4k+\*\*\*

Mother: Group home is billing the mother to cover the expenses of disabled daughter to AZ DES. Disabled members of the community are not being thoroughly considered during election years.

President James: Please stay after the chapter planning meeting to provide futher information to the officials for further guidance.
